

TERMS & CONDITIONS

It is a condition of public admission to the event ("Event") that all ticketholders comply with the following rules:

- 1. The ticket is purchased for the Event. The date of the Event and/or the support program may be subject to change without refund of monies or exchange of ticket. In the case of special conditions granted for individual ticket categories, Projekt Spielberg GmbH & Co KG reserves the right to change or restrict the conditions, number of offers and time period at any time. Tickets provided free of charge or at a reduced price can be tied to the purchase of tickets that are not reduced in number or in general. For example, up to two free children's tickets can be obtained with the purchase of an adult ticket, subject to availability. With regard to the event, refunds or exchanges are excluded, except in the event of cancellation of the event, unless in this case other legal provisions apply. No booking charge will be refunded if the Event is cancelled. No tickets are transferable to other events. Tickets to the Event are strictly nontransferable and not for resale. No ticket for the Event shall be sold or offered for sale for any form of fee or reward without the prior written consent of the Promoter first being obtained and without complying with these terms and conditions in all respects. No ticket for the Event shall be used by any person for advertising, promotional or commercial purposes including without limitation, prizes, competitions, contests, sweepstakes or packaged with hospitality or other products without the prior written consent of Projekt Spielberg GmbH & Co KG or another organizations first being obtained. The Promoter reserves the right to refuse admission to (or eject from) the Venue to any person (a) not complying with these terms and conditions or (b) who is in possession of a ticket which has been sold or used other than in compliance with these terms and conditions.
- 2. For good and valuable consideration, which receipt is acknowledged, the ticket holder grants the Circuit and their designees the right to use his/her image and/or likeness in any live or recorded display or other transmission or reproduction of the event, including without limitation his/her rights to publicity and/or commercial exploitation.
- You must not make, create, store, record or transmit any kind of sound recording, visual footage or audio-visual footage (Recording), or store, record or transmit any information or other data, including official timing results, performance, telemetry, weather or race control data (Data) of, at, or in relation to the Event. It is forbidden to take into the Venue any equipment that may enable you to do the aforementioned acts. Personal electronic devices (Including still image cameras, mobile telephones and other handheld personal communications devices) are permitted within the Venue unless otherwise advised, provided that any Recording, Data and any Image, including photographic Images and any still pictures derived or capable of being derived from a Recording (Image) of the Event that is recorded, stored and/or created thereon is used for personal, private and noncommercial purposes only.
- 4. As a condition of entry to the Venue you agree that (a) the use of any such Recording, Data or Image for any form of public advertisement display, commercial gain or for any other purpose (except for your private enjoyment) without the prior written consent is strictly forbidden and

will constitute a breach of these terms and conditions for which you may be liable and (b) on request by the Promoter or another organizations, you shall assign to them in writing the copyright and all other intellectual property in any Image or Recording that you create, make, store or record of, at or in relation to the Event.

- 5. The visitor acknowledges and agrees that records of his/her person in picture and sound may be made and may be used without temporal or local or objective restriction in any present or future media (e.g. TV, internet, data carriers, print) in connection with the advertisement of the event in any form or as often as desired.
- You hereby acknowledge that motor racing the Event 6. and certain activities associated therewith (including without limitation, support events) are dangerous. The Promoter, sanctioning bodies, another promoter and its affiliates, persons involved in the organization of the Event (including officials, marshals, rescue and medical staff), the competitors and drivers (such parties to include where relevant all directors, officers, employees, agents, contractors and affiliated companies), are not responsible for any loss or damage howsoever caused to you or your property to the maximum extent permitted by Austrian law (save that nothing in these conditions limits or excludes (i) liability for death or personal injury arising out of the negligence of any at the above mentioned parties, or (ii) any damage incurred by way of fraud or fraudulent misrepresentation by any of the above mentioned parties).
- It's forbidden to use the name of the Event or part thereof (nor any abbreviation or foreign language version thereof) nor any logo or graphic device of or relating to the Event for any commercial purpose without the prior written consent.
- 8. Upon receipt of the admission ticket, the visitor agrees to the operating regulations as amended in the current version.
- The instructions of security forces and stewarding service as well as the executive authorities must be followed at all times.
- Access to and staying in the venue is allowed only at the times defined by the organizer without any exception. Staying overnight or camping in the venue is not allowed.
- Stay on the marked paths. Blocking the stairs and escape routes, climbing over and sitting on the fences or barriers is prohibited.
- 12. It is forbidden to bring animals.
- 13. Motor sport and music events are noisy. We recommend to wear ear protectors during the event to reduce the risk of hearing damage. The organizer accepts no liability in this regard. It is recommended that children under the age of six are not brought to the event.

- 14. Bringing your own cold food (snacks) for personal use is permitted.
- 15. Persons who appear to be under the influence of alcohol or drugs will not be permitted to enter the event area or may be expelled from the premises and will not be entitled to a refund of the admission price.
- 16. Persons not complying with the owner's operating regulations or behave in a conspicuous manner by causing a disturbance may be expelled from the event area at any time.
- 17. Visitors are informed that the event site is monitored by means of video recordings and that these recordings may be used by the executive authorities for (criminal) prosecution against any visitor.
- Photos, videos, sound recordings and the like may be taken without exception for private and non-commercial purposes.
- **19.** The erection and display of posters in the entire area, including the forecourt, is only possible with the express written permission of the owner or organizer.
- **20.** The distribution of advertising material is only permitted with the prior written consent of the owner or organizer.
- 21. Official merchandising items will be sold within the event area. It is not permitted to purchase goods from nonofficial merchandisers. Furthermore, no merchandise of any kind may be sold, whether for a fee or free of charge, within the event premises or in the parking lots.

22. LIST OF PROHIBITED ITEMS

Spectators are prohibited from bringing objects of any kind that can be thrown or shot, or that could otherwise disturb or endanger the peace, order, and safety of the event site. This applies, but not exclusively, to the items listed below:

 Prohibited photo equipment at the grandstand: photo cases, photo bags, photo backpacks, monopods and multi-legged tripods, telephoto lenses over 180mm focal length and 20cm longer (from camera, incl. lens hood) This regulation applies ONLY to grandstands and does

NOT apply to standing areas, fan zones, etc. Beverage containers in the form of glass and other

- Beverage containers in the form of glass and other breakable bottles (except for unbreakable plastic bottles and customary cans)
- Barbecues, cookers and other appliances for preparing food
- Weapons of any kind and objects that have a weapon-like effect, such as knives, darts, etc.
- Articles and objects that can be used as weapons or projectiles, including in particular metal objects such as detachable chains, iron bars and iron pieces
- Laser pointers of any kind

 Pyrotechnical articles of all kinds; in general, the bringing in of fireworks, smoke bombs, incendiary devices, sticks, poles, garden and other large umbrellas, glass bottles, stones, stabbing, cutting and slashing objects as well as weapons of all kinds is prohibited

- Parasols in the seating area
- Drugs and stimulants
- Racist, xenophobic, right-wing extremist, Nazi, sexist or political propaganda materials
- (Domestic) animals
- Gas spray cans, caustic, flammable, coloring substances or containers with substances that may affect health or are easily flammable
- Bulky objects such as scaffolding, ladders, bicycles, skateboards, (electric) scooters, segways, hand or scooter carts, electric vehicles, and baby strollers
- Bulky, large bags, large backpacks, suitcases, and sports bags are prohibited for access to the stands. For the purpose of this provision, bulky items of luggage are all items that cannot be stowed in the ticket area
- Beach shells, tents, pagodas or similar structures and constructions.
- The use of unmanned equipment (e.g. drones) or model aircraft/unmanned aerial vehicles is strictly prohibited on the entire grounds.
- Cooling boxes
- all kind of alcoholic beverages

23. LIST OF ALLOWED OBJECTS

• Functioning mobile phones

- Cameras, film and video cameras with batteries for private use and NOT for commercial use (e.g. NO video cameras suitable for TV)
- Cameras and digital cameras may only be taken to the grandstands if they are no larger than a standard SLR camera with a standard lens up to a maximum focal length of 180mm or a maximum lens length of 20 cm. (from camera, incl. lens hood)
- Canes for the blind, walking aids
- Key rings, purse chains
- Medicines for personal use
- Flagpoles of up to 1.6m and less than 2cm diameter, if they do not obstruct the view; in general, access to the stands may be denied if flagpoles are brought along.
- Commercially available pocket lighters
- Binoculars
- Compact sun umbrellas and umbrellas in the standing-room area
- Folding chairs and folding armchairs in the standing area
- Plastic bottles and beverage cans

24. IMPORTANT NOTE

If light guns, rockets and/or firecrackers class II with more than 100 dB (e.g. "Supercobra 1-5", "Donnerschlag", etc.) or firecrackers class III and IV are found at access control, the persons bringing along such items are immediately prohibited from entering the premises.

25. These terms and conditions shall be governed by Austrian law excluding the UN Sales Convention and the referral rules of Austrian private international law.
